The following events for both men and women and all age groups will take place on either Saturday or Sunday:-

SATURDAY 11th MAY 2024 :

Senior & U20

100m, 400m, 1500m, Sprint Hurdles, High Jump, Triple Jump, Shot Putt, Discus

U17

100m, 300/400m, 1500m, Sprint Hurdles, High Jump, Triple Jump, Shot Putt, Discus

U15

100m, 300m, 1500m, Sprint Hurdles, High Jump, Triple Jump, Shot Putt, Discus

U13

100m, 1500m, Sprint Hurdles, High Jump, Shot Putt, Discus

SUNDAY 12th May 2024:

Senior & U20

200m, 800m, 5000m, 400mH, Long Jump, Pole Vault, Hammer, Javelin

U17

200m, 800m, 3000m, 300/400mH, Long Jump, Pole Vault, Hammer, Javelin

U15

200m, 800m, 3000m, Long Jump, Pole Vault, Hammer, Javelin

U13

200m, 800m, Long Jump, Javelin

NOTES TO COMPETITORS:-

- All events will be in accordance with UKA Rules
- Ambulant disabled athletes are welcome to compete in all suitable events.
- High Jump, Long Jump and Pole Vault: Normal rules apply
- Triple Jump: (Minimum Take Off Boards will be: SM 11m/13m, U20M 9m/11m, SW, U20W, U17M, U17W, U15G, U15B 7m/9m)
- Shot, Javelin, Hammer, Discus, Long Jump & Triple Jump: Each competitor has three trials with the top eight having an additional 3 trials.
- Sprint Hurdles: 70mH (U13G), 75mH (U13B/U15G), 80mH (U15B/U17W), 100mH (U17M/U20W/SW), 110mH (U20M/SM)
- U17s are restricted to 5 events on one day
- U13's and U15's can only enter 3 events on any one day. In addition they can only compete in one race of 800m or above on any day and as a result depending on the number of entrants these events may be run as time trials.
- This is a Level 1 Licenced Meeting.

REGISTRATION:-

- Please note that you must register and collect numbers for each event one hour before the scheduled start time and late arrival may result in being unable to compete.
- The Organising Committee reserves the right to alter the above when drawing up the timetable or on the day.

ENTRIES:

- Entry Fee per event is **£10** for Seniors and **£8** for all other age groups.
- Closing date for entries is **Midnight Sunday 28th April 2024**
- Timetables will be sent via e-mail and posted on the County website once entries have closed
- Entry will be via www.opentrack.run
- EA Registered Athletes are eligible to compete in these Championships by birth or 9 months continuous residence or have competed for the County (Broadly the area of Greater London north of the River Thames, west of the River Lea, East of the Colne and South of Hertfordshire)
- Please note:- England Athletics rules stipulate ATHLETES MAY COMPETE IN THE CHAMPIONSHIPS OF ONLY ONE COUNTY IN THE COMPETITIVE YEAR (OCTOBER 2023 TO SEPTEMBER 2024).
- EA Affiliated Club/Representative/School vests must be worn- UKA RULE T5 (143) S1 (4)
- Athletes in all Age Groups must have an up to date registration with their National Association as per UKA rule 20.

PLEASE NOTE THAT LATE ENTRIES WILL NOT BE ACCEPTED

AGE GROUP INFORMATION:

- U13s, U15s & U17s may only compete in up to three events on any day
- U20s may only compete in up to five events on any day
- Under 15, Under 17 and Senior Age Groups are as at Midnight 31/08/24
- Under 20 Age Group are Over 17 on 31/08/24 but Under 20 on 31/12/24
